

# RULES OF THE GEORGIA REPUBLICAN PARTY

---

## 1. MEMBERSHIP AND PARTICIPATION

### 1.1 QUALIFICATIONS FOR PARTICIPATION IN PARTY ACTIONS

All electors<sup>1</sup> who are in accord with the principles of the Republican Party, believe in its declaration of policy and are in agreement with its aims and purposes may participate as members of the Georgia Republican Party (hereinafter "GRP") in its conventions or mass meetings. All chairmen<sup>2</sup> and members of committees, delegates to conventions and voters in mass meetings, provided for in these Rules, shall be members of the GRP and must be electors of the respective units which they represent as chairmen, members, delegates, or voters in mass meetings.

### 1.2 PUBLICATION OF QUALIFICATIONS

The qualifications and conditions for participation in the GRP shall be published in all official calls for mass meetings and conventions called pursuant to these Rules and pursuant to the Rules and Call of the Republican National Convention.

## 2. STATE COMMITTEE

### 2.1 STATE COMMITTEE

While in session, the State Committee shall be the governing body (except while the State Convention of the GRP is in session) of the GRP, which is a political organization and political party. While in session, the State Committee shall be vested with all the duties, power, and

1 privileges possessed by the State Convention and the State Executive Committee. The State  
2 Committee, while in session, shall act for the GRP.

## 3 4 **2.2 MEMBERS**

5 The State Committee shall be composed of the following members who shall be voting members  
6 unless otherwise specified, and no person may simultaneously hold more than one voting  
7 position:

8 **A) State Chairman**

9 **B) National Committeeman**

10 **C) National Committeewoman**

11 **D) First Vice-Chairman**

12 **E) Second Vice-Chairman**

13 **F) Secretary**

14 **G) Assistant Secretary**

15 **H) Treasurer**

16 **I) Assistant Treasurer**

17 **J) The immediate past Chairman of the GRP.**

18 **K) General Counsel**

19 **L) Finance Chairman**

20 **M) The Chairs of the Under 80,000 and Over 80,000 Caucuses.** One county chairman  
21 elected by caucus of county chairmen from counties of 80,000 people or more and one county  
22 chairman elected by caucus of county chairmen from counties less than 80,000 people, which  
23 causes have been convened by the State Chairman at State Conventions where official business  
24 includes the biannual election of party officers. Population of the various counties for purpose of  
25 this provision shall be as determined by reference to the then most recent decennial U.S. Census.

26 **N) District Chairmen.** Elected by the District Conventions.

27 **O) At Large Members.** In addition to the District Chairmen, there shall be one hundred  
28 fifty (150) members elected by the various District Conventions of which one shall be allocated  
29 to each Congressional District and the remainder of which shall be allocated among the  
30 Congressional Districts in accordance with the number of votes cast therein for the Republican  
31 nominee for President in the immediately preceding General Election for such office.  
32

**P) Honorary Members**

The following members shall be considered honorary members *ex officio* of the State Committee, shall not have a vote and shall not be counted for a quorum, and shall not be present for any decision on expenditure of Party funds:

**1) Elected Officials**

- a) Georgia Republican United States Senators
- b) Republican Constitutional Executive Officers of Georgia elected statewide
- c) Georgia Republican Members of Congress
- d) The Republican majority or minority leaders of the Georgia House and Senate

**2) Allied Organizations**

- a) The President of the Georgia Federation of Republican Women
- b) The Chairman of the RNC Georgia Senior Republican Network
- c) The Chairman of the Georgia Federation of Young Republican Clubs
- d) The Chairman of the Georgia College Republicans
- e) The President of the Georgia Black Republican Council
- f) The State Chairman of the Georgia Teenage Republicans
- g) The Chairman of Georgia Republican Veterans
- h) The Chairman of the Hispanic Grassroots Taskforce

Allied Organizations are the former GRP Auxiliaries. These groups are officially recognized by the GRP for their activities. The GRP has no authority over these organizations and does not assume any responsibility or liability for their activities.

**Q) Non-voting members appointed by the State Chairman**

- 1) Parliamentarian
- 2) Chief Deputy General Counsel
- 3) Executive Director

**R) No person may hold more than one voting position on the State Executive or State Committee.**

### 3. STATE EXECUTIVE COMMITTEE

#### 3.1 AUTHORITY

The State Executive Committee shall have the duty, responsibility, power, and authority to conduct the affairs of the GRP between meetings of the State Committee and between State Conventions, including without limitation exercising statewide jurisdiction and control over party affairs.

#### 3.2 MEMBERSHIP

**A) Voting Members.** The Voting members of the Executive Committee of the State Committee shall be composed of those positions specified in Rule 2.2 (A) through (N) provided, however, that no person shall simultaneously hold more than one voting position.

**B) Non-Voting Members.** The following members shall be considered "honorary" members *ex officio* of the State Executive Committee, shall be non-voting members, shall not be counted for a quorum and shall not be present for any decision on expenditure of Party funds:

##### 1) Elected Officials

- a) Georgia Republican United States Senators
- b) Republican Constitutional Executive officers of Georgia elected statewide
- c) Georgia Republican Members of Congress
- d) The Republican majority or minority leaders of the Georgia House and Senate

##### 2) Allied Organizations

- a) The President of the Georgia Federation of Republican Women
- b) The Chairman of the RNC Georgia Senior Republican Network
- c) The Chairman of the Georgia Federation of Young Republican Clubs
- d) The Chairman of the Georgia College Republicans
- e) The President of the Georgia Black Republican Council
- f) The State Chairman of the Georgia Teenage Republicans
- g) The Chairman of Georgia Republican Veterans
- h) The Chairman of the Hispanic Grassroots Taskforce

Allied Organizations are the former GRP Auxiliaries. These groups are officially recognized by the GRP for their activities. The GRP has

no authority over these organizations and does not assume any responsibility or liability for their activities.

**3) GRP Officials**

- a) Chief Deputy General Counsel
- b) The Parliamentarian
- c) Executive Director

**4) Appointee of the Georgia Republican Party to the State Election Board**

**C) Voting Restriction.** Any voting member of the State Executive Committee who is also a member of a steering committee for a federal candidate shall not participate in decisions of the GRP with regard to the solicitation, transfer, donation or spending of funds.

**4. MEETINGS OF THE COMMITTEES**

**4.1 NOTICE; FREQUENCY OF MEETINGS; MINUTES**

Official meetings of the State Committee and the State Executive Committee shall be held on written notice setting forth the agenda mailed, faxed, or sent by written electronic communication not less than twelve (12) days prior to the meeting on the call of the Chairman or upon the written request of one-third (1/3) of the voting members the Secretary shall issue the call as provided in Rule 5.3. Attendance at a meeting of the State Committee or State Executive Committee by a member shall constitute a waiver by that person of any notice required for such meeting.

**A)** The Executive Committee shall meet not less than quarterly, provided, however, that two of those must be in-person meetings.

**B)** The State Committee shall meet not less than semi-annually, provided, however, that one of those must be an in-person meeting.

**C)** Written minutes of all business transacted at meetings shall be mailed, faxed, or sent by written electronic communication to every member of both committees within ten (10) days after each meeting.

**4.2 QUORUM**

A majority of the voting members present in person or by proxy shall constitute a quorum for the transaction of business.

1   **4.3    FORM OF PROXY**

2   All proxies shall be in writing, shall be signed by the maker, and shall be substantially in the  
3   following form:

14   **4.4    VOTING OF PROXIES**

15   Members may be represented by proxies, subject to the following conditions: (a) Any member  
16   may direct his proxy only to another voting member, (b) no proxy may be directed to or voted by  
17   the State Chairman, and (c) no member may vote more than five (5) proxies.

18  
19   **4.5    ATTENDANCE AND VOTING BY ELECTRONIC MEANS**

20   Official meetings of the State Committee and the State Executive Committee may be attended in  
21   person as provided in Rule 4.1 by physical attendance or by proxy as provided in Rule 4.4 at a  
22   place designated in the notice or, in the absence of a designated location, at the State  
23   Headquarters, or by audio, video or electronic conference call.

24         **A)** Except as to votes requiring a secret ballot, for issues requiring vote by the State  
25   Committee or the State Executive Committee either in favor or opposed to a certain proposition,  
26   the vote may be cast and taken by e-mail or other electronic means.

27                 1) All votes cast by electronic means shall be cast within five (5) business days of  
28                 submission to Members.

29                 2) A tally of all votes cast by electronic means shall be circulated to all Members  
30                 within eight (8) business days of submission to Members.

31                 3) A vote cast by electronic means shall have the same force and effect as a vote  
32                 cast by a Member casting a vote in person.

1           B) Votes cast and taken by audio or video conference call shall be taken pursuant to roll  
2 call vote.

## 3 4                                   **5. OFFICERS**

### 5       **5.1     DUTIES OF THE STATE CHAIRMAN**

6       The State Chairman shall be the Chief Executive Officer, chairman of the State Committee,  
7 chairman of the State Executive Committee and spokesman of the GRP and shall perform the  
8 duties required by these Rules, the State Convention, the State Committee, and the State  
9 Executive Committee. The State Chairman shall convene the State Committee and the State  
10 Executive Committee when the needs of the GRP require or at such other time as specified in  
11 Rule 4.1. The State Chairman shall preside at all State Committee meetings and State Executive  
12 Committee meetings and at all State Conventions until temporary organization of the Convention  
13 is completed. The State Chairman shall appoint all pre-convention committees with the approval  
14 of the State Executive Committee. The State Chairman shall be responsible for the general  
15 direction of the GRP. The State Chairman shall, with the approval of a majority of the State  
16 Executive Committee, appoint the General Counsel and Finance Chairman who shall be voting  
17 members of the State Committee and the State Executive Committee. The State Chairman shall  
18 appoint other members as provided in Section 2.2(P) and such other members as he deems  
19 necessary, who shall be non-voting members of the State Committee and shall fill any vacancies  
20 which shall occur in such positions due to death, resignation or removal. The State Chairman  
21 shall remove such officers and dissolve such committees when he deems desirable.

### 22 23       **5.2     DUTIES OF THE VICE-CHAIRMEN**

24           A) The First Vice-Chairman shall act in the absence of the State Chairman and shall  
25 perform other duties assigned by the State Chairman, the State Committee, or the State Executive  
26 Committee.

27           B) The Second Vice-Chairman shall serve under the direction of the State Chairman and  
28 shall act in the absence of both the State Chairman and First Vice-Chairman and shall have other  
29 such duties and responsibilities as assigned by the State Chairman, the State Committee, or the  
30 State Executive Committee.

1     **5.3     DUTIES OF THE SECRETARY AND ASSISTANT SECRETARY**

2           A) The Secretary shall keep minutes of State Committee and State Executive Committee  
3 meetings and shall be the custodian of those minutes. The Secretary shall also serve as secretary  
4 to all State Conventions until temporary organization of the Convention is completed. The  
5 Secretary shall give all notices required for meetings under these Rules and shall furnish copies  
6 of all minutes required. The Secretary shall, under the direction of the State Committee which  
7 shall meet for that purpose immediately before each State Convention, prepare the temporary roll  
8 of Delegates and Alternates of the said State Convention, placing thereon the names of all who  
9 are certified to the Secretary by the respective County Chairmen. Said roll shall govern the  
10 proceedings of the State Convention until changed by the State Convention itself. The Secretary  
11 shall keep a roster of the names and addresses of all County and District Chairmen and State  
12 Committee members and shall perform such other duties prescribed by the State Committee.

13           B) The Assistant Secretary shall, subject to the direction of the Secretary, assist the  
14 Secretary in the performance of the duties of the Secretary and in the absence of the Secretary  
15 shall perform those duties.

16  
17     **5.4     DUTIES OF THE TREASURER AND ASSISTANT TREASURER**

18           A) The Treasurer shall have the custody and responsibility of the funds of the GRP, shall  
19 deposit said funds in a bank or banks selected by the State Executive Committee, which funds  
20 may be drawn as prescribed by the State Executive Committee. The State Executive Committee  
21 shall annually secure an audit. The Treasurer shall present at each State Committee meeting and  
22 State Executive Committee meeting a financial report. The Treasurer shall be an accountant,  
23 bookkeeper, CPA, or financial advisor

24           B) The Assistant Treasurer shall, subject to the direction of the Treasurer, assist the  
25 Treasurer in the performance of the duties of the office of Treasurer and in the absence of the  
26 Treasurer, perform those duties and have the right to vote at any meeting of the State Committee  
27 and State Executive Committee. The Assistant Treasurer shall be an accountant, bookkeeper,  
28 CPA, or financial advisor.

29           C) Upon the authorization of any two of the following, one of which must be elected, the  
30 State Chairman, Treasurer, Assistant Treasurer, Executive Director, and such person as the State  
31 Chairman shall designate with the approval of the State Executive Committee, shall have the

1 authority to draw checks on GRP bank accounts and shall be covered by a fidelity bond in an  
2 amount deemed appropriate by the State Executive Committee.

#### 3 4 **5.5 DUTIES OF THE FINANCE CHAIRMAN**

5 The Finance Chairman shall be Chairman of the State Finance Committee and shall be  
6 responsible for raising the funds of the GRP and for obtaining adequate financing for the GRP.

#### 7 8 **5.6 DUTIES OF THE PARLIAMENTARIAN**

9 The Parliamentarian shall be responsible for all interpretation of GRP Rules.

#### 10 11 **5.7 DUTIES OF THE GENERAL COUNSEL AND CHIEF DEPUTY GENERAL** 12 **COUNSEL**

13 A) The General Counsel shall be responsible for providing legal advice to the GRP.

14 B) The Chief Deputy General Counsel shall be responsible for such duties prescribed by  
15 the General Counsel and, in the absence of the General Counsel, perform those duties and have  
16 the right to vote at any meeting of the State Committee and State Executive Committee.

#### 17 18 **5.8 DUTIES OF THE UNDER 80,000 AND OVER 80,000 CAUCUS CHAIRS**

19 The chairs of the Under 80,000 and Over 80,000 caucuses shall have such duties and  
20 responsibilities as assigned to them by, and shall serve under the direction of, the State  
21 Chairman.

#### 22 **5.9 DUTIES OF OTHER OFFICERS**

23 The other officers shall have the normal duties attendant to such offices not inconsistent with  
24 these Rules, and such other duties as may be prescribed by the State Committee or the Executive  
25 Committee.

#### 26 27 **5.10 TERM LIMITS**

28 Effective upon the convening of the 2012 State Convention, no person may be elected to the  
29 position of National Committeeman or National Committeewoman who shall have been elected  
30 to and have served at least three (3) four-year terms in such position and no person may be  
31 elected to the position of State Chairman who shall have been elected to and have served at least  
32 three (3) two-year terms in such position.



## **6. COMMITTEES**

### **6.1 PERMANENT RULES COMMITTEE**

The Chairman shall appoint, with the approval of the State Executive Committee, a permanent Rules Committee consisting of one (1) member from each congressional district and not less than four (4) and no more than five (5) members at large ensuring an odd number of members for the committee. This member from each Congressional District shall be selected from a list of not less than three (3) persons recommended by their respective District Chairs. Two (2) of the remaining members at large shall include the State General Counsel and the State Parliamentarian, with the other members being named by the State Chair from the existing State Committee or State Executive Committee. The permanent Rules Committee shall make a report concerning the Rules at each meeting of the State Committee.

### **6.2 STATE FINANCE COMMITTEE**

The State Finance Committee shall adopt rules to govern its operation not inconsistent with the Rules, subject to revision by the State Committee.

### **6.3 COMMITTEE ON APPEALS**

All appeals made to the State Committee under this rule shall first be referred to a subcommittee known as the Committee on Appeals. The Committee on Appeals shall be appointed by the State Chairman. The Committee on Appeals shall investigate the matter referred, review appropriate documents, receive and review written representations from the parties involved in the dispute which may include a stenographic record, testimony and other evidence. The Committee may hold hearings if it deems necessary. For each case referred to it, the Committee on Appeals shall make a report of its findings, including a proposed judgment, to the State Committee not more than seventy-five (75) days from receipt of the appeal by the Appeals Committee. The State Committee shall vote on the report and proposed judgment of the Committee on Appeals not more than forty-five (45) days after receipt of the report and proposed judgment. In all cases the decision of the State Committee shall be final, and there shall be no appeal from the decision of the State Committee.

4   **7.1    ELECTION OR APPOINTMENT OF CERTAIN OFFICERS, NATIONAL**  
5           **COMMITTEEMAN, NATIONAL COMMITTEEWOMAN AND NATIONAL**  
6           **CONVENTION DELEGATES AND ALTERNATES**

7           A) In odd numbered years, the State Convention shall elect State officers, including the  
8   Chairman, the First Vice-Chairman, the Second Vice-Chairman, the Secretary, the Assistant  
9   Secretary, the Treasurer, and the Assistant Treasurer. In Presidential Election Years, the State  
10   Convention shall elect the National Committeeman and National Committeewoman and  
11   Delegates at Large and Alternates at Large to the Republican National Convention in accordance  
12   with Rule 7.3. For the 2013 – 2015 term, the Assistant Treasurer shall be elected by the State  
13   Committee in accordance with the terms of Rule 7.7.

14  
15   **7.2    STATE PRIMARIES AUTHORIZED BY STATE CONVENTION OR STATE**  
16           **COMMITTEE**

17   Any State Convention or State Committee meeting duly constituted under these Rules, may by a  
18   majority vote of those present, authorize and approve the holding of primary elections, either  
19   statewide or within any Congressional District, County or other political subdivision of Georgia  
20   for the election of officers, Delegates or Alternates of the GRP or any of its appropriate political  
21   subdivisions and may prescribe such rules and regulations, including the time of qualification,  
22   which are consistent with Georgia law.

23  
24   **7.3    ELECTION OF NATIONAL CONVENTION DELEGATES**

25           A) In accordance with these Rules, the Call of the Republican National Committee and  
26   as allowed by the Georgia Presidential Preference Primary Act, as amended, the Delegates and  
27   Alternates to the National Convention shall be elected from the Districts at the respective District  
28   Conventions and the Delegates and Alternates to the National Convention from the State at large  
29   shall be elected at the State Convention and shall be bound to vote for the Presidential nominee  
30   elected in the Georgia Presidential Primary, as provided in the Georgia Presidential Preference  
31   Primary Act, as amended. (See O.C.G.A. § 21-2-190, et seq. The GRP does not, therefore,

1 choose to elect any of its Delegates and Alternates to the Republican National Convention by  
2 primary.

3       **B)** The Republican Presidential candidate receiving the highest number of votes in the  
4 Presidential Preference Primary in each Congressional District shall receive all votes of such  
5 Congressional District Delegates and seated Alternates to the Republican National Convention.  
6 The Republican Presidential candidate receiving the highest number of votes in the Primary  
7 statewide shall receive all statewide (State at Large) Delegate and seated Alternate votes to the  
8 Republican National Convention, and such Delegates and Alternates shall file a qualification  
9 oath as required by O.C.G.A. § 21-2-196.

10  
11 **The following was adopted by the State Committee on September 24, 2011 as a temporary**  
12 **amendment to the Rules for the 2012 Presidential election cycle:**

13  
14               B) Delegates and Alternates shall be apportioned as follows:

15  
16               1) No State at large Delegate or Alternate shall be allocated to any candidate who  
17 receives 20% or less of the vote in the Georgia Presidential Preference Primary.

18  
19               2) No fractional Delegate or Alternate shall be allocated.

20  
21               3) In each Congressional District, the three (3) Delegates and three (3) Alternates shall be  
22 allocated proportionally based on the following: (1) any candidate who receives the  
23 majority (50% + 1) of the Congressional District's Presidential Preference Primary  
24 vote shall be allocated all three (3) of the Congressional District delegates and  
25 alternates; (2) if no candidate receives the majority (50% + 1) of the Congressional  
26 District's Presidential Preference Primary vote, the candidate receiving the highest  
27 number of the Congressional District's Presidential Preference Primary votes shall be  
28 allocated two (2) delegates and two (2) alternates and the candidate receiving the  
29 second highest number of the Congressional District's Presidential Preference Primary  
30 votes shall be allocated one (1) delegate and one (1) alternate.

1           4) At large Delegates and Alternates shall be allocated by numerical slot to the  
2           candidate(s) receiving more than 20% of the vote based on his or her percentage of the  
3           Statewide Presidential Preference Primary vote. Any remaining Delegates and  
4           Alternates not allocated initially shall be apportioned sequentially and in order to  
5           candidate(s) receiving an initial allocation. For the purpose of this allocation, RNC  
6           Delegates (State Chairman, National Committee Woman and National Committee  
7           Man) shall be considered at large delegates and be allocated to the candidate receiving  
8           the largest percentage of the vote.

9  
10          5) All Delegates and Alternates shall file a qualification oath as required by O.C.G.A. §  
11          21-2-196.

12  
13          C) Except as provided in Section 7.3.B., hereinabove, a District Convention may  
14          instruct, commit or pledge the Delegates and Alternates to the National Convention elected by it.  
15          Except as provided in Section 7.3.B., hereinabove, the State Convention may instruct, commit or  
16          pledge the Delegates and Alternates to the National Convention elected by it. However, no  
17          District Convention or State Convention may instruct, commit or pledge the Delegates and  
18          Alternates to the National Convention so as to conflict with the provisions of these Rules. This  
19          Rule applies to both nominations for President and Vice President of the United States. The  
20          failure of a District Convention to instruct its Delegates and Alternates shall not give the State  
21          Convention the power to instruct such Delegates and Alternates elected by the District  
22          Convention.

23          D) The State Executive Committee is delegated the authority to take such additional acts  
24          as may in its discretion be required for the GRP to comply with the provisions of the Georgia  
25          Presidential Preference Primary Act, as amended.

#### 26 27      **7.4   TERMS OF OFFICE**

28          The terms of the members of the State Committee and the State Executive Committee who are  
29          elected at a convention shall begin immediately following the adjournment of the convention at  
30          which each was elected. The terms of other members of the State Committee and State  
31          Executive Committee shall begin upon the occurrence of the respective event which qualifies  
32          each for membership on the State Committee or State Executive Committee.

1     **7.5     REMOVAL OF STATE OFFICERS**

2             A) Any State officer, other than those appointed by the State Chairman, may be removed  
3 from office for cause by a vote of a two-thirds (2/3) of a quorum present at any duly called  
4 meeting of the State Committee; provided however, such individual must be given written notice  
5 of said meeting mailed or circulated by written electronic communication at least thirty-two (32)  
6 days in advance thereof, setting forth the grounds for removal, and be given an opportunity to be  
7 heard in person or by his representative. "Cause" as used herein shall include continued failure  
8 to perform his duties or conduct detrimental to the best interests of the GRP, all as may be  
9 determined by the two-third (2/3) vote of a quorum of the State Committee.

10            B) Absent dispensation by the committee with appropriate jurisdiction, if a member of  
11 the State Committee, a District Committee, or a County Committee shall publicly advocate the  
12 election of another candidate for an office for which the Republican Party has nominated a  
13 candidate, that member shall be removed from party office.

14            C) As soon as an officer qualifies to run for an elected public office for which at least one  
15 other Republican has also qualified, he shall be deemed to have resigned. An officer who  
16 qualifies as a candidate for an elected public office for which no other Republican has also  
17 qualified shall be deemed to have resigned immediately upon being elected to that office. As  
18 soon as an officer qualifies as a candidate for elected office as a candidate of any political party  
19 other than the Republican Party, he shall be deemed to have resigned all positions in the GRP.  
20

21     **7.6     RESTRICTIONS ON ENDORSEMENTS BY GRP OFFICIALS**

22     Members of the State Executive Committee, the State Committee, GRP employees, appointed  
23     GRP Officials, County Chairmen, members of any County Committee and members of any  
24     District Committee shall not use their official title in any manner in connection with their support  
25     of, any candidate for the Republican nomination for any public office in the State of Georgia in  
26     primaries where there is at least one other Republican candidate.  
27

28     **7.7     FILLING VACANCIES IN OFFICES ELECTED BY THE STATE**  
29     **CONVENTION**

30     In the event of death, resignation, or removal from office of any elected State officer except State  
31     Chairman and National Committeeman and National Committeewoman, the State Executive  
32     Committee shall elect a successor by a majority vote of a quorum present. In the event of a

1 vacancy in the position of State Chairman, the First Vice-Chairman shall automatically serve as  
2 acting Chairman until the State Committee elects a State Chairman. In the event of a vacancy in  
3 the position of National Committeeman or Committeewoman, the State Committee will elect a  
4 replacement. In the event of a vacancy in the position of Treasurer, the State Chairman shall  
5 immediately appoint an acting Treasurer until the State Executive Committee elects a successor.  
6 If any such vacancies are not filled within ninety (90) days after those vacancies occur, the State  
7 Executive Committee may fill such vacancies by a majority vote on its own motion. All  
8 resignations are deemed to be effective upon notice. No vote to accept a resignation shall be  
9 required.

#### 10 11 **7.8 FILLING VACANCIES IN STATE COMMITTEE POSITIONS ELECTED BY** 12 **DISTRICT CONVENTIONS**

13 In the event of the death, resignation, or extended failure to function of a State Committee  
14 member elected by a District Convention, the District Executive Committee shall fill such  
15 vacancy and shall notify the State Secretary at the GRP headquarters within five (5) days after  
16 the election. If such vacancy is not filled within ninety (90) days after it occurs, the State  
17 Executive Committee may fill such vacancy by a majority vote on its own motion.

#### 18 19 **7.9 CANDIDATES FOR THE ELECTORAL COLLEGE**

20 The Republican nominees for the Electoral College shall be elected by the State Executive  
21 Committee; provided, however, such election may be by primary if authorized by the State  
22 Committee, certified to the Secretary of State as provided by law.

### 23 24 **8. DISTRICT, COUNTY AND LOCAL ORGANIZATION**

#### 25 26 **8.1 RESIDENCY REQUIREMENT**

27 The Georgia Election Code refers to "Election Districts" as "Precincts." Only electors of the  
28 Precinct, County, or Congressional District (as the case may be), may serve on the respective  
29 committees described in this Section 8.

1  
2 **8.2 CONGRESSIONAL DISTRICT COMMITTEES, OFFICERS AND MEMBERS**

3 There shall be a committee in each Congressional District officially known as the "                      
4 Congressional District Republican Committee" hereinafter the "District Committee." The  
5 District Committee shall be composed of a District Chairman, a First Vice-Chairman, one or  
6 more Vice-Chairmen, a Secretary, a Treasurer, State Committee members and such additional  
7 officers and members as shall be provided in the District Rules.  
8

9 **8.3 CONGRESSIONAL REAPPORTIONMENT**

10 When Congressional Districts are reapportioned, these Rules shall be deemed amended, so that  
11 the officers and members of the Congressional District Committees for the Congressional  
12 Districts which result from the Reapportionment shall be determined as follows:

13       **A)** The highest ranking officer who, on the date the new Congressional District became  
14 legally effective, was an officer of a Congressional District Committee and who is an elector in  
15 the new Congressional District, shall serve as temporary presiding officer for purposes of  
16 convening a meeting of the Congressional District Committee as provided in this Section. In the  
17 event that there is more than one officer of the same rank, the convening officer shall be  
18 determined (1) by the ranking officer whose delegates represent the majority in the new District,  
19 or (2) if the majority cannot be determined, the convening officer shall be determined by drawing  
20 lots.

21       **B)** The Congressional District Committee shall consist of Committeemen who, on the  
22 date the new Congressional District was determined, were serving as committeemen of a  
23 Congressional District Committee, and who are electors of the new Congressional District.

24       **C)** The Congressional District Executive Committee shall be likewise constituted as set  
25 out above, substituting the term "District Executive Committee" for "District Committee."

26       **D)** The Congressional District Committee, as comprised pursuant to Section 8 shall meet  
27 upon ten (10) days' notice to its members to elect officers of the Congressional District to serve  
28 until the next Congressional District Convention as provided in Section 8.5 and Section 9.  
29  
30  
31  
32

1     **8.4     DUTIES OF DISTRICT COMMITTEE**

2           **A)** The District Committee shall make arrangements in each odd-numbered year and  
3 each Presidential Election year for the purpose of holding District Conventions consistent with  
4 these Rules and the State Call.

5           **B)** In the event of controversies, other than those involving the election of National  
6 Convention delegates and alternates, originating within the District GRP organization, petition  
7 shall first be made to the District Committee by filing with the District Chairman, setting forth  
8 the particulars of the controversy. Said petition by at least five (5) qualified Republican voters  
9 shall be filed with the District Chairman no later than thirty (30) days from the date of the  
10 alleged event giving rise to the controversy. The petition shall be heard by the District  
11 Committee within forty-five (45) days following receipt by the District Chairman. For each case  
12 referred to it, the District Committee shall make a report of its findings and decision to the  
13 parties involved not more than forty-five (45) days from receipt of the appeal. Appeals of such  
14 District Committee decisions may be made to the State Committee within thirty (30) days from  
15 the date of said decision, if signed by twenty-five (25) qualified Republican voters of the  
16 District. Said appeal shall then be heard by the State Committee as provided in Rule 6.3. Said  
17 petition shall be filed with the State Secretary at GRP headquarters. The foregoing shall not  
18 apply to appeals to the District Committee arising from action of County Committees, as those  
19 shall be handled in accordance with Paragraph 8.4 (C) below.

20           **C)** The District Committee shall hear any appeals arising from a County Committee in  
21 accordance with Rule 8.8, with the right of petition to the State Committee. Appeals from  
22 County Committees to the District Committee shall be investigated by the District Committee by  
23 reviewing appropriate documents and written representations from the parties involved in the  
24 dispute, which may include a stenographic record, testimony and other evidence. The District  
25 Committee may hold hearings if it deems necessary. For each case referred to it, the District  
26 Committee shall make a report of its findings and decision to the parties involved not more than  
27 forty-five (45) days from receipt of the appeal.

28           **D)** The District Committee shall have such other functions as assigned by the State  
29 Committee. The District Committee may provide in its rules for a District Executive Committee  
30 with powers as provided in its rules.



1     **8.5     ELECTION OF DISTRICT OFFICERS AND STATE COMMITTEE MEMBERS**

2     The officers and members of the District Committee and representatives to the State Committee  
3     elected from their respective Districts shall be elected in odd numbered years by the respective  
4     District Conventions. They shall begin office at the adjournment of the District Convention and  
5     shall hold office for two years and until their successors are duly elected and qualified, unless  
6     sooner removed from office in accordance with these Rules. As soon as an officer qualifies as a  
7     candidate for an elected public office for which at least one other Republican has also qualified,  
8     he shall be deemed to have resigned. An officer who qualifies as a candidate for an elected  
9     public office for which no other Republican has also qualified shall be deemed to have resigned  
10    immediately upon being elected to that office. As soon as a member qualifies as a candidate for  
11    elected office as a candidate of any political party other than the Republican Party, he shall be  
12    deemed to have resigned all positions on the District Committee.

13  
14    **8.6     DUTIES OF THE DISTRICT CHAIRMAN**

15    The District Chairman shall be the chief executive officer of the District Committee. The  
16    District Chairman shall convene the District Committee when the needs of the Party may require  
17    or as required by the District Rules. He shall preside at meetings of said District Committee and  
18    the District Executive Committee. He shall appoint such additional officers (nonvoting) and  
19    committees as he deems advisable. The District Chairman shall send written notices mailed or  
20    circulated by written electronic communication at least ten (10) days in advance to all Delegates  
21    and Alternates of the time, place and date of the Congressional District Convention, which notice  
22    shall indicate that the Congressional District Convention is to be held pursuant to the State Call.

23  
24    **8.7     COUNTY COMMITTEES AND THEIR OFFICERS AND MEMBERS**

25    There shall be a committee in each County officially known as the “\_\_\_\_\_ County  
26    Republican Committee” hereinafter the “County Committee.” The County Committee shall be  
27    composed of a County Chairman, First Vice-Chairman, Vice-Chairman, a Secretary, a Treasurer,  
28    and such additional officers and members as may be determined by the County Convention, with  
29    not less than one member from each Precinct in said County in which there was a Mass Meeting,  
30    or a combined Mass Meeting as provided in Rule 9.2(A). The County Conventions shall elect  
31    County Delegates and Alternates to the District and State Conventions. The County Committee  
32    exercises county-wide jurisdiction and control over party affairs, as defined by and required

1 under O.C.G.A. § 21-2-111, which powers may in part be delegated as provided in these rules  
2 and the County Rules to a subcommittee of the County Committee called the "County Executive  
3 Committee." As soon as an officer qualifies to run for an elected public office for which at least  
4 one other Republican has also qualified, he shall be deemed to have resigned. An officer who  
5 qualifies as a candidate for an elected public office for which no other Republican has also  
6 qualified shall be deemed to have resigned immediately upon being elected to that office. As  
7 soon as an officer qualifies as a candidate for elected office as a candidate of any political party  
8 other than the Republican Party, he shall be deemed to have resigned all positions on the County,  
9 Municipal, Precinct or other GRP governing committees.

#### 11 **8.8 DUTIES OF THE COUNTY COMMITTEES**

12 A) The County Committee shall publish a notice of the State Call and make  
13 arrangements for the County Convention and the Precinct Mass Meetings and fix the basis of  
14 representation by Delegates to the County Convention and the time and place for holding the  
15 County Convention consistent with these Rules and the State Call. It shall cooperate with the  
16 State Committee and its District Committee in conducting all elections, conventions, and  
17 meetings within its boundaries.

18 B) Each County Committee shall decide all controversies arising within its jurisdiction,  
19 with a right to appeal the decision of the County Committee to the District Committee. In the  
20 event of controversies arising within the County GRP organization, petition shall first be made to  
21 the County Committee. Said petition by at least qualified five (5) qualified voters as defined in  
22 Rule 1.1, setting forth the particulars of the controversy shall be filed with the County Chairman  
23 no later than thirty (30) days from the date of the alleged event giving rise to the controversy.  
24 The petition shall be heard at the next regularly scheduled County Committee meeting, but in no  
25 event more than forty-five (45) days following receipt by the County Chairman of the petition.  
26 Appeals of the County Committee decision may be made within thirty (30) days from the date of  
27 the decision appealed from by petition signed by at least five (5) qualified voters as defined in  
28 Rule 1.1 if the county had fewer than 100 elected delegates to its last County Convention or at  
29 least twenty-five (25) qualified voters as defined in Rule 1.1 if the county had 100 or more  
30 elected delegates to its last County Convention. Said appeal shall be heard by (a) District  
31 Committee if the County is located entirely within a district or, (b) the District Committee of the  
32 District having a plurality of the elected delegates from the respective County to the most recent

1 District Convention. Appeals to the District Committee shall be filed with the District Chairman.  
2 There shall be a right to file a petition to request that the State Committee review the decision of  
3 the District Committee on appeals under this Rule. Said petition by at least five (5) qualified  
4 voters as defined in Rule 1.1 setting forth particulars of the controversy shall be filed with the  
5 State Secretary at GRP headquarters. The State Secretary shall refer such petition to the  
6 Committee on Appeals. The Committee on Appeals, may, in its discretion, hear such petition or  
7 recommend to the State Committee that the State Committee summarily affirm the decision of  
8 the District Committee. If the Committee on Appeals elects to hear the petition, it shall do so in  
9 accordance with Rule 6.3.

## 10 11 **8.9 ELECTION OF COUNTY OFFICERS AND MEMBERS OF THE COUNTY** 12 **COMMITTEE**

13 The officers and members of the County Committee shall be elected in odd-numbered years by  
14 the respective County Conventions. They shall begin office at the adjournment of the County  
15 Convention and shall hold office for two years and until their successors are duly elected and  
16 qualified, unless sooner removed in accordance with these Rules.

## 17 18 **8.10 DUTIES OF COUNTY CHAIRMAN**

19 The County Chairman shall be the chief executive officer of the County Committee. The County  
20 Chairman shall preside at all meetings of the County Committee and the County Executive  
21 Committee. He shall appoint such additional officers (nonvoting) and committees as he deems  
22 advisable. The County Chairman shall appoint a temporary presiding officer for each Mass  
23 Meeting or consolidated Mass Meeting (as the case may be), who shall preside until a temporary  
24 chairman is elected. The temporary presiding officer shall not necessarily be an elector of the  
25 area in which the Mass Meeting was held. The County Chairman shall appoint interim County  
26 Convention Committees and their respective Chairmen subject to the approval of the County  
27 Committee. Except as provided in Rule 9.2(B), the County Chairman shall send written notices  
28 mailed or circulated by written electronic communication at least ten (10) days in advance to all  
29 Delegates and Alternates of the time, place and date of the County Convention, which notice  
30 shall indicate that the County Convention is to be held pursuant to the State Call.

1   **8.11   PRECINCT COMMITTEEMEN**

2   Any vacancies on the Precinct Committee not filled pursuant to Rules 9.1 or 9.4 may be filled by  
3   the County Committee. Except as provided in Rule 9.1, each Precinct Committee shall elect its  
4   own Chairman and other officers in accordance with any applicable County Party Rules or  
5   otherwise as it deems necessary.

6  
7   **8.12   REPUBLICAN MUNICIPAL EXECUTIVE COMMITTEE**

8   The County Committee is authorized to provide rules or adopt regulations as it deems necessary  
9   or desirable to establish a municipal Executive Committee in each municipality principally  
10   located in said County for the purpose of encouraging participation in any partisan municipal  
11   election including the nomination of Republican candidates therein. Said organization shall be  
12   consistent with the Rules of the Georgia Municipal Election Code.

13  
14   **8.13   NOTICE AND FREQUENCY OF MEETINGS**

15   Meetings of the District, County and Precinct Committees shall be held upon written notice  
16   mailed, faxed, or sent by written electronic communication at least ten (10) days in advance  
17   unless otherwise provided by their respective rules, on the call of the Chairman or on the call of  
18   one-third (1/3) of the members. Each District and County committee shall meet at least twice  
19   each year. Each committee shall transact all other necessary and proper business of the Party.

20  
21   **8.14   QUORUM**

22   Twenty-five percent of the voting members of each District, County and Precinct Committee,  
23   present in person or by proxy, shall constitute a quorum for the transaction of business, unless a  
24   greater number is otherwise provided by their respective rules.

25  
26   **8.15   PROXIES**

27   Where District or County Committee rules specifically permit, members of the District, County  
28   and Precinct Committees may be represented by proxy; provided however, that a proxy may be  
29   given only to a member of the respective committee.

1 **8.16 REMOVAL FROM OFFICE OF DISTRICT, COUNTY, AND PRECINCT**  
2 **OFFICERS AND COMMITTEEMEN**

3 A) Any officer or member of a District, County or Precinct Committee may be removed  
4 from office for cause by his respective committee on the same terms and conditions as prescribed  
5 in Rule 7.5(A) or 7.5(B) for removal of officers and members of the State Committee.

6 B) Whenever the State Committee determines that any County or District Chairman or  
7 other officer is subject to removal for cause as defined in Rule 7.5(A) or 7.5(B) and remedial  
8 action has not been taken as provided in Rules 8.16(A) and 8.17 within thirty (30) days after  
9 written notice has been mailed or circulated by electronic communication to such County and  
10 individual, the State Committee shall remove such Chairman or officer and shall appoint a new  
11 Chairman or officer. The Chairman or officer thus appointed shall perform the duties of the  
12 office until his successor is duly elected at a County or District Convention.  
13

14 **8.17 VACANCIES IN OFFICES OF DISTRICT, COUNTY,**  
15 **AND PRECINCT COMMITTEES**

16 Vacancies created by death, resignation, removal from office, or other cause of any District,  
17 County or Precinct Chairman, officers or Committee members shall be filled by a majority vote  
18 of a quorum present of the voting members of the respective committee, unless rules of the  
19 District, County or Precinct provide otherwise.  
20

21 **9. MASS MEETINGS AND CONVENTIONS**

22 **9.1 THE STATE CALL**

23 A) Pursuant to the Call issued by the State Committee there shall be held in each odd-  
24 numbered year and in each Presidential Election year Mass Meetings in each Precinct which  
25 shall elect Delegates and Alternates, as set forth in the Call, to the respective County  
26 Conventions, and in each odd-numbered year shall also elect Precinct officers and Precinct  
27 Committeemen. The Call shall be issued a reasonable time prior to the Mass Meetings and shall  
28 include a copy of all forms to be used. The County Conventions in odd-numbered years shall  
29 elect officers and organize the Party in the respective Counties for the next two years and in both  
30 odd-numbered and in Presidential Election years shall elect Delegates and Alternates, as set forth  
31 in the Call, to the Congressional District and State Conventions. The District Conventions in  
32 odd-numbered years shall elect officers, District Committee members, and State Committee

1 members for the next two years and in Presidential Election years shall elect National Delegates  
2 and Alternates as set forth in the Call to the Republican National Convention.

3       **B)** A copy of the Call shall be sent by the State GRP headquarters to each County  
4 Chairman and Congressional District Chairman. The County Chairman, upon receipt of this  
5 Call, shall cause a meeting of the County Committee to be held to publish notice of the Call for  
6 Mass Meetings, the County Convention and Congressional District Conventions.

## 8 **9.2 HOLDING OF MASS MEETINGS**

9       **A)** In accordance with the Call, Mass Meetings shall be held in, and for, each Precinct  
10 for the purpose of electing Delegates and Alternates by precinct to County Conventions;  
11 provided, however, that a County Committee may adopt a plan to hold multiple Precinct Mass  
12 Meetings in locations grouped by other political subdivisions. Such a plan may also provide for  
13 the consolidation of certain administrative functions of the Mass Meeting, e.g., appointment of a  
14 single Mass Meeting Chairman, registration committee, etc., but may not provide for any  
15 consolidation of Precincts for the election of Precinct officers and Committeemen or County  
16 Convention Delegates and Alternates. Any such plan must be submitted in writing by the  
17 County Chairman to the State Executive Committee to the attention of the State Chairman at  
18 GRP headquarters at least forty-five (45) days in advance of the date of the Mass Meetings. If  
19 the State Executive Committee takes no action on the plan at least thirty (30) days prior to the  
20 Mass Meetings, it is deemed approved and the County may proceed with this plan. Should any  
21 precinct not caucus or not elect a full delegation, any unfilled delegate or alternate slots may not  
22 be filled by any other precinct or by the Mass Meeting.

23       **B)** Notwithstanding any of the above, Counties whose population according to the last  
24 census was 80,000 or fewer shall hold both their Mass Meetings and County Conventions at a  
25 location described in Section 9.7 and at the time set by the Call for County Conventions. The  
26 County Executive Committee in such a County may elect to opt out of the requirements of this  
27 Rule but it must give written notice of such election to the State Executive Committee not later  
28 than December 1st prior to the Convention in order for such option to be effective.

1   **9.3    PUBLICATION OF NOTICE OF MASS MEETINGS**

2       A) Each County Chairman shall cause to be printed in a newspaper of general circulation  
3 in each County the notice of the time and place of each Mass Meeting not less than fifteen (15)  
4 days before the date of said Mass Meeting and by such other notice as may be directed by the  
5 County Committee. The time and place of the County and Congressional District Conventions  
6 shall be included in this notice. The County Chairman shall send to the State Secretary at GRP  
7 headquarters a written or electronic copy of the publication of notice, together with the other  
8 documents required by Rule 9.12, including the date of publication, within five (5) business days  
9 after publication. [See Rule 9.11(A)].

10       B) The only required published notice shall be for Mass Meetings. In the notice  
11 published by Counties under 80,000 where the Mass Meetings and County Convention are held  
12 under Rule 9.2(A), the notice shall specify that the Mass Meetings and County Convention will  
13 be held at separate times on the same date at the same place. County Chairmen shall provide a  
14 written or electronic copy of the notice to the State Secretary at GRP headquarters within five (5)  
15 business days after publication.

16  
17   **9.4    DEFERRED MASS MEETINGS**

18 Where for any reason a Mass Meeting is not conducted on the date set in a Call for such  
19 meetings in odd-numbered years, any person in a Precinct interested in the organization of a  
20 Precinct Committee may file a written petition, at any time after the State Convention held in  
21 such odd-numbered years, with the County Committee requesting that a Precinct Mass Meeting  
22 be called. Upon receipt of such request, the County Committee shall determine by a majority  
23 vote of a quorum present whether or not such Precinct Mass Meeting should be held and if so,  
24 the County Committee shall instruct the County Chairman to call and preside at, or appoint a  
25 temporary presiding officer to preside at such Precinct Mass Meeting until a temporary  
26 organization can be effected; provided however, that any such Precinct Mass Meeting shall be  
27 governed by all the rules applicable, including publication of notice in the newspaper and the  
28 holding in a public place, where practicable.

29  
30   **9.5    MEETINGS & CONVENTIONS OPEN TO PUBLIC**

31 The Mass Meetings and Conventions shall be open to the public as spectators.  
32

1   **9.6    ONLY ELECTORS WHO ARE DELEGATES AND SEATED ALTERNATES**  
2       **MAY VOTE**

3   Only qualified, registered, resident electors of a given Precinct, Rule 9.2(A) District, County, or  
4   Congressional District may vote or be elected as a Delegate or Alternate or hold office in the  
5   respective Mass Meeting or Convention.  
6

7   **9.7    USE OF PUBLIC BUILDINGS**

8   Mass Meetings shall be held in buildings appropriate for public use, where practical and, except  
9   in the case of a Rule 9.2(A) consolidation, within the geographic limits of the political  
10   subdivision for which the Mass Meeting is conducted. The County Conventions shall be held in  
11   buildings appropriate for public use, where practical, in the respective Counties. Congressional  
12   District Conventions shall be held in buildings appropriate for public use, where practical, in the  
13   respective Congressional Districts.  
14

15   **9.8    ALLOCATION OF DELEGATES TO COUNTY CONVENTIONS**

16   Each Precinct shall be entitled to one Delegate and one Alternate to the County Convention. In  
17   addition each Precinct shall be entitled to one additional Delegate and one additional Alternate  
18   for each 50 votes and major fraction thereof (26 or more) cast for the Republican candidate for  
19   President in the immediately preceding general election. Votes cast in advance and absentee  
20   voting, where a precinct determination cannot be made, shall be allocated to the precincts in the  
21   same percentage as those cast on election day. At the discretion of the County Committee, in  
22   Counties having population of over one hundred thousand (100,000), each Precinct shall be  
23   entitled to one Delegate for each one hundred fifty (150) votes and major fraction thereof (76 or  
24   more) cast for the Republican candidate for President in the immediately preceding general  
25   election, with each Precinct having at least one (1) Delegate. Such determination must be made  
26   at least by the time of the Precinct Mass Meetings and the State Executive Committee must be  
27   notified. Any county which has had changes in precinct lines since the last Presidential Election  
28   may use the vote totals cast for the Republican candidate for Governor in the immediately  
29   preceding general election to allocate their county convention delegates. In such case the  
30   formula used to calculate the number of delegates and alternates for each precinct shall be the  
31   same as previously stated in this section.  
32



1     **9.9     DEFERRED COUNTY CONVENTIONS**

2     Where for any reason a County Convention is not conducted on the date set in a Call for such  
3     Conventions in odd-numbered years, any person in such County interested in the organization of  
4     a County Committee may file a written petition with the District Committee for the District in  
5     which the County is located requesting that a County Convention be called. Where a County is  
6     located within one or more Districts, the County Committee may file a written petition with the  
7     State Executive Committee requesting that a County Convention be called. Upon receipt of such  
8     request, the District or State Committee shall determine by a majority vote of a quorum of its  
9     members whether or not such County Convention should be held and if so the District or State  
10    Committee shall instruct the District or State Chairman to call and preside at, or appoint a  
11    temporary presiding officer to preside at such County Convention until a temporary organization  
12    can be effected; provided however, that any such Conventions as herein provided, to the extent  
13    applicable, including publication of notice in the newspaper and holding in a public place, where  
14    practicable.

15  
16    **9.10    ALLOCATION OF DELEGATES TO DISTRICT AND STATE CONVENTIONS**

17    Each County shall be entitled to one Delegate and one Alternate to the State Convention. In  
18    addition, each County shall be entitled to one Delegate and one Alternate for each one-thousand  
19    (1000) votes or major fraction thereof (501 or more), cast for the Republican candidate for  
20    President in the last general election. Each County shall be entitled to one Delegate and one  
21    Alternate to the District Convention. In cases of split counties, said delegate shall be allotted to  
22    the District with the largest number of votes cast for the Republican candidate for President in  
23    the last general election. In addition, each County shall be entitled to one Delegate and one  
24    Alternate for each seven hundred fifty (750) votes or major fraction thereof (376), cast for the  
25    Republican candidate for President in the last general election. Delegates and Alternates may  
26    not be transferred among Counties within a District.

## 9.11 REPORTS AND FILING OF CREDENTIALS

**A) Mass Meetings.** Immediately after adjournment of the Mass Meeting, the Chairman of the Mass Meeting shall file a list (including residence addresses, telephone numbers, and email addresses if provided) of Delegates and Alternates elected to each respective County Convention, certified<sup>3</sup> by the Chairman and Secretary of the Mass Meeting with the Chairman of the County in which the Mass Meeting was held along with (in odd-numbered years) a certified list of the Precinct officers and committeemen duly elected at said Mass Meeting. One set of the lists will be retained by the Mass Meeting Secretary. The County Chairman shall within five (5) business days of adjournment of Mass Meeting send a copy of the list of Delegates and Alternates to the County Convention to the Secretary of the State Committee at GRP headquarters.

**B) County Conventions.** Immediately after the adjournment of the respective County Conventions, the Chairman of the County Convention shall file a list (including residence addresses and telephone numbers) of the Delegates and Alternates elected to the Congressional District and State Conventions, certified by the Chairman and Secretary of the County Convention with the State Secretary at GRP headquarters, accompanied by (in odd-numbered years) the convention minutes and a certified list of the officers and members of the County Committee duly elected by the County Convention along with evidence that the call and notice were published as required in the Rules, and with the Chairman of each Congressional District in which the County is located, accompanied by (in odd-numbered years) a certified list of the officers and members of the County Committee of the County organization duly elected at the Committee. A copy of the lists will be retained by the Secretary of the County Committee. The copy of the list must be addressed and postmarked or delivered to the appropriate authority within five (5) days of the adjournment of the respective convention.

**C) Congressional District Conventions.** Immediately after the adjournment of the District Convention, the Chairman of the District Convention shall file with the State Secretary at GRP headquarters (in odd-numbered years) a certified list (including residence addresses, telephone numbers, and email addresses if provided) of the members of the State Committee and the officers and District Committee of the Congressional District organization duly elected at the Convention accompanied by the convention minutes, and (in Presidential Election years) a

1 certified list (including residence addresses and telephone numbers) of the National Delegates  
2 and Alternates elected with the State Secretary at GRP headquarters. The GRP, in turn, shall file  
3 with the Secretary of the Republican National Convention the list of National Delegates and  
4 Alternates elected at said Congressional District Convention, as required by the Rules adopted by  
5 the most recent Republican National Convention. A copy of the lists will be retained by the  
6 Secretary of the Congressional District Committee. The copy of the list must be addressed and  
7 postmarked or delivered to the appropriate authority within five (5) days of the adjournment of  
8 the respective convention.

#### 10 **9.12 ADOPTION AND FILING OF COUNTY AND DISTRICT RULES**

11 At each County Convention and at each District Convention, rules shall be adopted for the  
12 respective County and District, not inconsistent with the Rules of the GRP. A certified copy of  
13 the County Rules shall be filed: (1) within five (5) business days of the adjournment of the  
14 County Convention, or the date of adoption of any amendment, as the case may be, with the  
15 District Chairman of each applicable District and with the Secretary of the State Committee; and  
16 (2) in accordance with the Georgia Election Code, within thirty (30) days after the adjournment  
17 of the County Convention, or the date of adoption of any amendment, as the case may be, with  
18 the election superintendent<sup>4</sup> of the County. A certified copy of the District Rules shall be filed  
19 with the Secretary of the State Committee within five (5) business days following the  
20 adjournment of the District Convention or the date of adoption of any amendment thereto, as the  
21 case may be.

#### 22 **9.13 ACCESS TO LISTS OF DELEGATES AND ALTERNATES**

23 Any elector offering as a candidate for the position as a party officer, Delegate or Alternate shall  
24 be entitled to access on an equitable basis to the lists of the Delegates and Alternates who are  
25 certified to vote in the elections for these positions.

#### 27 **9.14 SAMPLE FORMS**

28 A) Sample forms for Mass Meetings shall be furnished by the GRP and shall be sent to  
29 the County Chairman for delivery to the Precinct or political subdivision Chairman.

1           B) Sample forms for County Conventions shall be furnished by the GRP and shall be  
2 sent to the County Chairman.

3           C) Sample forms for Congressional District Conventions shall be furnished by the GRP  
4 and shall be sent to the Congressional District Chairman.

5  
6   **9.15 ELECTION OF DELEGATES AND ALTERNATES**

7           A) Conventions shall attempt to elect a number of Alternates equal to the number of  
8 Delegates. Delegates and Alternates to the County, District, State and National Conventions do  
9 not have to be present and in attendance to be elected as Delegates or Alternates to the  
10 Convention at which they are elected to serve as Delegates or Alternates to another convention.

11          B) Delegates and Alternates shall not be paired. The Delegates of each delegation shall  
12 by caucus and by majority vote adopt a plan for the seating of Alternates for any missing  
13 Delegates of their delegation.

14  
15   **9.16 UNIT RULE**

16 No unit rule may be imposed by a Precinct, County, District, or State Convention on any  
17 Delegate elected by it.

18  
19   **9.17 NO CONVENTION BUSINESS WHILE COMMITTEES ARE IN SESSION**

20 No official business shall be transacted at any Convention while any of its Committees are in  
21 session.

22  
23   **9.18 RULES OF ORDER**

24 Unless modified by these Rules or those of any organization listed herein or by the State Call, the  
25 latest edition of Robert's Rules of Order, Newly Revised shall be followed in all meetings and  
26 conventions of the GRP, including, without limitation, the State Committee, the State Executive  
27 Committee, the District Committee, the District Executive Committee, the County Committees,  
28 the County Executive Committees, the Mass Meetings, and the State, District and County  
29 Conventions.

30  
31   **9.19 STATE CONVENTION PROCEDURES**

32          A) Resolutions shall be considered at the State Convention as provided in the Call.

1           B) The Permanent Rules Committee shall prepare recommended rules and orders of  
2 business for the conduct of each State Convention in advance thereof, which rules and order of  
3 business shall be submitted to the rules committee of each State Convention for its consideration  
4 and report to the State Convention in session.  
5

## 6                           **10. CONDUCT OF REPUBLICAN PRIMARIES**

### 7           **10.1 NOMINATION OF CANDIDATES AND SELECTION OF PARTY OFFICIALS**

8           The State Committee, or the State Executive Committee upon failure of the State Committee to  
9 act, may adopt and promulgate rules in accordance with Georgia law, providing for the manner  
10 of substitute nominations in the event a candidate nominated by a GRP primary should die,  
11 resign or otherwise become disqualified.  
12

### 13           **10.2 RULES FOR PRIMARIES**

14           The State Convention or the State Committee may adopt rules for the conducting of Republican  
15 primaries consistent with the provisions of Georgia law and these Rules. Such rules, if adopted,  
16 shall be appended as Appendix "A" to these Rules.  
17

### 18           **10.3 OATH OF AFFIRMATION OF CANDIDATES**

19           Any candidate for elective office running as a Republican Party candidate shall submit to the  
20 appropriate level of the Party the following oath affirming his or her allegiance to the party by  
21 signing the following oath<sup>5</sup>:

22           I DO SWEAR OR AFFIRM MY ALLEGIANCE TO THE GEORGIA REPUBLICAN PARTY.

## 26                           **11. MISCELLANEOUS RULES**

### 27           **11.1 AMENDMENTS TO THESE RULES**

28           These Rules may be amended at any State Convention of the GRP by a 2/3rds vote of a quorum  
29 present or by the State Committee by a three-fourths (3/4) vote of a quorum present. If the Rules  
30 are amended at a State Committee meeting, the meeting must be duly held after written notice

1 mailed, faxed, or sent by written electronic communication at least twelve (12) days prior to the  
2 meeting to all members of the State Committee setting forth in detail the proposed amendments.  
3

#### 4 **11.2 EFFECTIVE DATE OF THESE RULES**

5 These Rules and any amendments thereto, shall become effective upon the filing of a copy of the  
6 same, certified by the State Chairman, with the Georgia Secretary of State or upon such later date  
7 as may be specified therein.  
8

#### 9 **11.3 EFFECT OF REORGANIZATION**

10 The parliamentarian is directed that the rules as reorganized on April 2, 2011 will be interpreted  
11 to implement and accomplish the original purpose of the rules, and the reorganization is not  
12 intended to change the substance of any rule.
